



Premier Cricket Livestreaming Consent & Release Form

This form must be viewed and approved by any person that will feature in a live streamed Premier Cricket Club match, including players and match officials (“Participants”) and (if the Participant is aged under 18) their parent/legal guardian.

MATCHES WILL BE LIVE STREAMED

Premier Cricket matches that your Premier Cricket Club participates in will be live streamed during the 2023/24 season.

Live video and audio of these matches will be recorded and broadcast online. The live stream will be publicly available on the SACA match centre (contact SACA for more details).

Recording equipment at match may record your image, voice and other identifying features. Please observe appropriate standards of behaviour, conduct and language in or around the live streaming devices, whose presence will be marked by signage at the match. By proceeding to submit this form and attending or participating in the relevant match, you are consenting to the recording and use of the information more publicly, as described.

USE OF THE LIVE STREAM FOOTAGE, IMAGES OR SOUND

Footage, images or sound from the livestream may be used by:

- the Premier Cricket Club
- SACA
- representatives, agents, partners or authorised licensees of SACA (including Interact Sport Pty Ltd)
- other parties such as disciplinary tribunals or third party arbiters, who may have requirements to review or otherwise rely upon the live stream footage for investigatory, disciplinary, complaint management, training or educational purposes.

The footage, images or sound from the live stream may be used by these parties for the following purposes:

- training and education purposes, such as skill correction, analysis, performance assessment or for development of training tools;
- promotional or marketing purposes, for example, footage or images may be featured on the Premier Cricket Club or SACA website, social media pages or in other publications;
- for commercial purposes, such as commercialisation of highlights packages, selling or licensing broadcasting rights to third parties, use of the footage, sound or images in connection with product or service endorsements, or to obtain sponsorships; and
- for investigatory, complaint management, or disciplinary purposes, for example, footage, images or sound from the livestream may be used as evidence in any investigation, hearing or disciplinary process brought in under relevant competition rules or complaint management policies.

CONSENT AND RELEASE

I give permission for my (and/or the under 18 Participant's) image or physical likeness (both in video and photo), voice, name and/or biographical information to be featured on the live stream and used for the purposes set out in this form.



I relinquish (and/or relinquish on behalf of the under 18 Participant) any rights, title or interest that I (and/or the under 18 Participant) may have in the live stream footage, images or sound and agree that (the under 18 Participant and/or) I have no rights to fees, remuneration or royalty in exchange for my (or their) appearance in the live stream.

I agree (and/or agree on behalf of the under 18 Participant) that SACA will be the sole owner of all rights, title and interest in the live stream images, footage and sound, and will have unrestricted and perpetual rights to use (and consent to or licence the use of) the images, footage or sound for the purposes set out above.

PRIVACY
